## SUMMER HOUSING GUIDELINES AND APPLICATION 2018

### UNDERGRADUATE STUDENTS

During the summer, Lindenwood University offers housing only to students who are enrolled in summer classes. Students may only reside on campus during the time-frame of their classes. Housing availability is limited to resident halls during the summer. Due to staff restrictions, yearly maintenance, and upkeep in our residence halls, only Calvert Rogers hall is open for all residents. The deadline to apply for summer housing is May 3, 2018. Summer housing applications must be submitted to the Office of Residential Life no later than May 3 via StarRez.

Terms and Conditions for Summer Housing:

1. Students are responsible for the residential charge. The residential charge is \$175 per week (June 3 – July 27, 2018). This rate includes 2 meals a day (a boxed lunch and a hot dinner buffet) Monday - Friday. Meals will not be provided on the weekends. **Students will not have the option to opt out of meals.**
2. Students must complete an online summer housing application via StarRez online housing portal (deadline to apply is May 3).
3. Students must comply with the check-in and check-out dates established by the Office of Residential Life for each summer session they are attending (see dates below).
4. Students in Lindenwood University's non-traditional housing are required to move to a residence hall on campus. Students are responsible for removing all belongings from their previous housing assignments and completing a proper check-out. Lindenwood does not provide any type of storage, and non-traditional housing on campus is not an option for storage during the summer months.
5. Single rooms are not offered during summer housing.
6. Students must follow the same rules and policies in the residence halls during the summer sessions as they do during the regular academic year.
7. In the event a student drops his or her summer session class, the student is required to move out of the summer housing assignment.

### GRADUATE STUDENTS

MBA and quarter (ADP) students are subject to being re-located in the summer. For example, if a graduate student lives in a residence hall that will be closed, the student will have to relocate for the summer. A housing assignment for the summer term is required to ensure a room assignment is available in the open residence hall.

## INTERIM PERIOD (May 7 - June 1, 2018)

Consisting of four weeks, students signed up for housing during the summer session have the option to pay the same weekly summer rate (\$175/week) to remain in campus housing. This rate includes 2 meals a day (a boxed lunch and a hot dinner buffet) Monday - Friday. Meals will not be provided on the weekends. Students will not have the option to opt out of meals. Students will be notified by the Office of Residential Life when they will be relocated to their summer housing assignment.

## TRANSITION PERIOD (July 30 - Aug 25, 2018)

There is a four-week break between the end of the summer session and the beginning of the fall semester 2018. Students enrolled in a summer session class (course ending July 27th) can remain on campus for \$250/week. This covers housing and two meals a day Monday - Friday (boxed lunch and hot dinner) and brunch and dinner on Saturday - Sunday. Students will not have the option to opt out of meals. Students will be moved to their fall housing assignment.

*\*Every student is responsible for notifying the Office of Residential Life of any changes in his/her summer schedule immediately, as this may affect check-in and check-out dates as well as housing assignments.*

### **CHECK-IN and CHECK-OUT INFORMATION**

Check-in will be the Sunday prior to the start of your class and check-out will be the Saturday after the class ends.

### **NOTE:**

Due to the number of different course offerings during the summer, you will have to fill in the start and end dates for the class you signed up for in the StarRez portal.
