## **Biographical Information:**

**Robert H. Frank** is the Henrietta Johnson Louis Professor of Management and Professor of Economics at Cornell's Johnson Graduate School of Management and a Distinguished Senior Fellow at Demos. His books, which include <u>Choosing the Right Pond</u>, <u>Passions Within Reason</u>, Microeconomics and Behavior, Principles of Economics (with Ben Bernanke), <u>Luxury Fever</u>, <u>What Price the Moral High Ground?</u>, <u>Falling Behind</u>, <u>The Economic</u> <u>Naturalist</u>, <u>The Darwin Economy</u>, and <u>Success and Luck</u>, have been translated into 23 languages. The Winner-Take-All Society, co-authored with Philip Cook, received a Critic's Choice Award, was named a Notable Book of the Year by The New York Times, and was included in Business Week's list of the ten best books of 1995. He is a co-recipient of the 2004 Leontief Prize for Advancing the Frontiers of Economic Thought.

<u>Charles Murray</u> is an Emeritus Scholar at the American Enterprise Institute. A political scientist, author, and libertarian, he first came to national attention in 1984 with the publication of <u>Losing Ground</u>, which has been credited as the intellectual foundation for the Welfare Reform Act of 1996. His 1994 New York Times bestseller <u>The Bell</u> <u>Curve</u>, co-authored with the late Richard J. Herrnstein, sparked heated controversy for its analysis of the role of IQ in shaping America's class structure. Dr. Murray's other books include <u>What It Means to Be a Libertarian</u>, <u>Human</u> <u>Accomplishment</u>, <u>In Our Hands</u>, <u>Real Education</u>, and the New York Times bestseller <u>Coming Apart</u>. His most recent book, <u>By the People: Rebuilding Liberty Without Permission</u> urges Americans to stem governmental overreach and use America's unique civil society to put government back in its place.

Marc Cox, Master of Ceremonies – Marc Cox has been the host of "The Marc Cox Show" on FM News Talk 97.1 since 2010. He is an Emmy award-winning 25 year veteran of television news with a career that covered five states, four TV stations and three radio stations. He spent 19 of those years here in St. Louis on CBS affiliate KMOV-TV as an anchor, reporter and producer and covered some of the nation's biggest stories. Along the way he was honored by the Associated Press and the National Academy of Television Arts and Sciences, receiving multiple Emmy nominations and two Emmy awards. **Bill McClellan**, Q&A Session Moderator -- Bill McClellan is likely the most well-known writer in the Saint Louis area, and in 1999 was inducted into the Saint Louis Walk of Fame. He has been a columnist for the *St. Louis-Post Dispatch* since 1980, where he won the Saint Louis Newspaper United Media Guild's <u>2017 Terry Hughes Award</u> for writing. He is also a panelist on the KETC public affairs show <u>Donnybrook</u>.
