## **Hammond Institute Hosts Dr. Douglas Husak from Rutgers University on September 21**

*Session will address the mass incarceration crisis, and also feature local panelists Doug Burris, Thomas Utterback.*

**WHO:** Members of the local community, faculty, staff, and students will have an opportunity to attend a crucial discussion featuring Professor Douglas Husak from Rutgers University. The session, to be held on the Lindenwood University campus, will address the causes of mass incarceration.

The evening event will begin with Dr. Husak's presentation – *The Partisan Politics of Overcriminalization* – and segue to a panel discussion on the topic of mass incarceration, also featuring Doug Burris, chief United States probation officer for the Eastern District of Missouri, and Thomas Utterback, critical analyst consultant.
