



### **Student Immunization Requirements & Information**

#### **ALL INCOMING STUDENTS ARE REQUIRED TO HAVE THE FOLLOWING IMMUNIZATIONS:**

- Tuberculosis (TB) Screening
- Meningococcal waiver or vaccine

#### **HOW TO SUBMIT YOUR DOCUMENTS:**

Once you enroll in classes, then you will receive an email from Castle Branch providing you a link to an immunization portal. This email contains a link called “Begin Order,” that allows you to create an account on Castle Branch and complete the requirements. Once an account is created, you will have a “To Do List”.

#### **WHAT TO SUBMIT:**

For Meningococcal:

- Can provide vaccine records OR
- Complete the waiver that is provided on the portal

For Tuberculosis (TB):

- Fill out the questionnaire that is on the portal
- If you answer ‘no’ to all 6 questions, then no TB test is needed and the questionnaire can be uploaded
- If you answer ‘yes’ to 1 or more questions, then a TB test with a negative result is required

#### **IMMUNIZATION RECORD DUE DATES:**

Failure to provide the required immunization documents may result in an academic hold being placed on your account.

**June 3, 2022** - Summer Students

**September 16, 2022** – Semester Undergraduate and Graduate, Fall I Students

**October 28, 2022** – Fall II Students

**January 31, 2023** - Semester Undergraduate, Semester Graduate, Spring I Students

**April 7, 2023** - Spring II Students

#### **EXEMPT STUDENTS:**

Students who are enrolled in an online degree program, Early College Start students, and any student born before 1956 are all exempt.

#### **APPLICABILITY, DOCUMENTATION, AND ENFORCEMENT:**

The immunization requirement applies to all domestic and international students entering Lindenwood University for the first time and any returning student who was not enrolled for the previous term, unless medical or religious exemptions pertain. Students in the Nursing program may have additional immunization requirements.

You must satisfy the immunization requirement completely prior to registration for your next academic term. Failure to provide the required immunization documents may result in an academic hold being placed on your account.

The University also reserves the right to deny access to campus facilities, including residence halls, if documentation of compliance has not been provided. Further, in accordance with public health recommendations, non-immune students may be excluded from the University campus in the event of a measles, rubella, or mumps outbreak or other public health recommendation.
